



# AZORA ACQUIRES SEVEN HOTELS AND SIGNS A COLLABORATION AGREEMENT WITH MED PLAYA

- The portfolio of 1,670 keys is located in Benidorm and Costa del Sol
- Azora will carry out the refurbishment and repositioning of the assets
- Med Playa Group will continue with the management of the hotels

**Madrid, May 9<sup>th</sup>, 2019.** Azora has acquired seven hotels in Spain from Med Playa Group. The portfolio has a total of 1,670 keys distributed among the Hotel Pez Espada in Torremolinos and the Hotel Riviera in Benalmádena, both located in Costa del Sol and throughout the hotels Flamingo Oasis, Río Park, Riudor, Regente and Agir; all five located in Benidorm.

Azora will carry out the refurbishment and repositioning of the hotels for a total of €30 million to increase their category mainly to 4\*, while Med Playa Group will continue with the management of the assets for a period of up to 35 years. Azora and Med Playa will continue to collaborate in future investments.

With this transaction, Azora bets on Benidorm and Costa del Sol, two of the most consolidated touristic destinations in Spain, which have recorded excellent tourism results throughout the years, both among Spaniards and foreigners. In particular, Benidorm, which accounted more than 11 million overnight stays and 2 million tourists in 2018, reached an occupancy level of 84% throughout the year, its second best rate within the last 15 years. Furthermore, it is worth noting that Benidorm is the first Spanish municipality to receive the intelligent touristic destination certificate granted by the Spanish Touristic Quality Institute (Instituto para la Calidad Turística Española (ICTE)). This certificate shows its strength as a sustainable and accessible touristic





destination with a clear focus on the use of new technologies, good governance and innovation.

Azora, who managed more than 13,000 keys through Hispania, considers that the hotel sector still offers numerous investment opportunities with which to generate added value through repositioning and active asset management, and is thus in the process of raising a new fund to invest in resort hotels throughout the Mediterranean and in hostels in the main touristic cities within Europe.

"This transaction shows Azora's firm decision to continue investing in the hotel sector, specially if we can go alongside a hotel operator with more than 50 years' experience such as Med Playa" says Concha Osácar, Founding Partner of Azora.

"Through this agreement we see the opportunity of growing in Spain alongside Azora, reinforcing our position as hotel operator specialised in resorts" says Agustí Codina, President of Med Playa.
